THIS DEED OF DECLARATION OF TRUST executed at Pattukkottai on this 14th day of November 2019 by:

Mr. B. SHEIK ABDULLAH S/O. Batcha, (Aadhar Number 7007 4373 0512) aged 37 years residing at No: 46, North Street, Pattukkottai, Thanjavur District - 614601, here in after called the "Founder, Chairman and Managing Trustee" of the Trust:

Whereas the Founder of the Trust is desirous of forming a Trust or Charitable objects and as already invested a sum of Rs.1000/- infavour of this Trust and therefore felt it desirable to reduce in writing the objects of the Trust as under:

1. The Name of the Trust shall be "**GOLDEN EDUCATIONAL TRUST** " and the Registered office of the Trust shall be presently at **No: 34, II floor, Big Street, Pattukkottai, Thanjavur Dist. – 614 601**, in a rented building, which may be changed from time to time to such other places as the Trustees may deem fit and proper at his discretion.
2. It is hereby agreed and declared that the Trustees shall hold the said amount herein after referred to as "**THE TRUST**" which expression, shall include and be deemed to include all cash amount, moneys and properties movable to immovable acquired for or gifted or donated to this Trust, by any other person or any associations and organizations, companies etc., whatsoever and be provided upon the following uses the powers and on the terms and conditions herein after contained of any concerning the Trust.
3. **THE OBJECTS OF THE TRUST:**
 - a) To promote education and culture by establishing and managing educational institutions like schools, colleges, Universities and other Educational institutions, scientific, commercial, industrial and Technical and do all the things that are necessary for establishment, management and promotion of such institutions. The Trust may also take up the managements of such Institutions established by any similar Trust or Association registered under the Societies Registration Act or any other enactment in force or that may be brought into force by the State or Central Government.



- b) To establish, run, support and grant aid or other financial assistance to schools, colleges, and libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- c) To establish, conduct, maintain and / or manage reading rooms, libraries, and institutions for promotion of fine arts, tape libraries, both audio and video, gymnasiums, workshops, publishing houses, printing presses, hotels, residential quarters and the like.
- d) To establish, maintain and run studentship, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex.
- e) To encourage, assist and create self –employment opportunities to the educated unemployed in the society.
- f) To do any other act of charitable nature, general public utility and any act for the furtherance of objects, for which the Trust is created and to carry out all incidental and all ancillary activates of the Trust without discrimination of class, creed, community or religion.



(4) BOARD OF TRUSTEES :

1. **Mr. B.Sheik Abdullah S/o. Batcha, (Aadhar Number 7007 4373 0512)** aged 37 years residing at No: 46, North Street, Pattukkottai, Thanjavur District - 614601, as **Founder, Chairman and Managing Trustee**
2. **Mrs. B.Shajahan Beevi, W/o. Batcha, (Aadhar Number 7407 5570 6284)** aged about 57 years, residing at No:46, North Street, Pattukkottai, Thanjavur District - 614601, **Co-Trustee,**
3. **Mr.B.Ashik Abdullah, S/o. Batcha, (Aadhar Number 9583 5702 3015)** aged about 33 years, residing at No:46, North Street, Pattukkottai, Thanjavur District – 614601 as **Vice Chairman (Co-Trustee)**

The Trustees on mutual consent among themselves may co-opt any person/or persons as trustee who may be helpful in achieving the objects of the trust.

5. APPOINTMENT & TENURE OF OFFICE OF MANAGING TRUSTEE:

At present the Founder Trustee of the First Part Mr.SHEIK ABDULLAH act as Managing Trustee of the Trust.

The term of office of Managing Trustee and Correspondent of the Educational Institutions is for a period of Ten Years. The vacancy of office of Managing Trustee and Correspondent of Educational Institutions shall be filled in rotation among the trustees. Any vacancy arising in the office of the Managing Trustee and Correspondent with in a period of ten years of assuming office by any cause, shall be filled in by the next founder Trustee who is eligible for appointment in rotation.




6. TENURE OF OFFICE OF TRUSTEES:

I. The tenure of the trustees shall be for life subject to the power vested in the Board of Trustees.

II. Any vacancy arising in the office of the Founder Trustees shall be filled up only with his family members or nominees if legal successor not alive either male or female and not from outside.

7. POWERS OF THE BOARD OF TRUSTEES


- I. The board of Trustees shall in general have the powers to offer their suggestions and views in the matter of running of the Trustees shall have the right to administer the Trust.
- II. In the matter of implementing the objects of the Trust, the decision of the Board of Trustees shall be absolute and shall not be called upon for being questioned by any aggrieved person in any court of law.
- III. The Board shall have powers to frame regulations and bye-laws for carrying out the objects of the Trust and also have powers to modify or amend such bye-laws, rules and regulations within the frame-work of the Trust.
- IV. The Board shall have the right to appoint other persons as Trustees and also to Co-opt. Persons in the vacancy caused in the posts of Trustee. Such persons not necessarily be from family of the Founder Trustees.
- V. The Board may decide to pay such remuneration as they think fit from time to time, either monthly or otherwise for the services rendered by the Managing Trustee and or Correspondent of the Educational Institutions. The founder Trustees or other Trustees working in the institutions of the Trust will be paid salary as per the government scales and institutions.

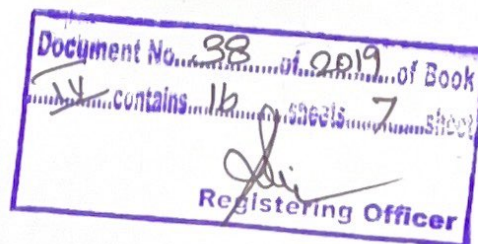

- VI. The Board shall have powers to let property or any buildings which may be purchased in the future on behalf of the trust for such terms and years at such rent and subject to such conditions, stipulations or provisions as the trusted shall determine.
- VII. The Board shall have also power to mortgage or charge the properties of the trust or any part thereof to secure repayment of any sum or sums or money which the trustees may borrow on the security thereof.
- VIII. The Board shall have also power to accept from any person or persons or institutions contributions in money and property either by way of addition to the trust funds generally or for any one of more of the specified objects of the trust and in either case such a contribution shall be dealt with either as capital or as income according to the directions of donars at the time of gift.
- IX. The Board shall have power to sell and convert into cash the trust properties and realize any or all of the securities and investment and to reinvest them in such manner as they deem fit from time to time.
- X. The Board shall have full power of management of the trust properties and funds and they shall have control over the finance of the trust.
- XI. The Board shall be entitled to take all steps that may be reasonable necessary or required for the preservation of the trust, the trust properties and of the title of the trust to the properties.
- XII. The Board may from time to time formulate and after the rules and regulations for the proper conduct of the trust and its objects by recording the same in a minute book. Where the donations to this trust enjoy the benefits of section 80G of the Indian income Tax Act 1961 prior approval of the commissioner of income Tax is required to formulate and the rules and regulations.



- XIII. The Board is hereby authorized to appoint a Manager and to pay him out of the trust fund such as salary as the Board think fit. The Board can delegate such secretarial or other work to the manager and it deem fit.
- XIV. The Board may also appoint any other staff for the day to day functioning of the trust and pay such remuneration mutually decided.
- XV. To invest the Trust fund in such manner as the Trustees feel in their absolute discretion and it is here by expressly provided that it shall be obligatory upon them to invest the same only in the investment referred to in the Indian Income Tax Act 1961 as amended from time to time particularly under the provisions of Sec.13 (1) (d) read with Sec.15 (5) of the Act.
- XVI. To enter in to agreements, contracts, and cancel or vary them
- XVII. To receive any money and to grant receipts in discharge thereof.
- XVIII. To do all other Act or things as are Incidentally Conductive or expedient to the attainment of the trust.

8. POWER OF THE MANAGING TRUSTEE:

- I. The Managing Trustee shall have power to invest the money to the Trust.
- a. In any of the Securities by section 20 of the Indian Trust Act 1882 and in accordance with Rule 67 & 101 of the Income Tax Rules Whichever is applicable.
- b. In accordance with the Prevision of the Income Tax Act 1961 and any rules framed and or to be framed there under in the Purchase of lands and buildings provided that such. Investment shall be made by unanimous decision of the Board and are satisfied that such investment will be a steady sources of income to the Trust and will yield a reasonable net income of the outlay or deemed necessary for carrying out of the objects of the trust.



- c. In fixed deposits with any banks, in any other Government approved Investment.
- d. The Funds of the trust may at the discretion of the board be invested in such other manner as may be decided from time to time.

II. To institute, prosecute, defend and compromise all actions and proceeding before the Government, Court Tribunals, Authorities including suits, appeals, reviews and revisions, execution and the like and to represent the trust before them.

III. To enter into any compromise and to refer the matter to exhortation.

IV. To make generally all such acts, deeds, and things on behalf of the trust as may be necessary or expedient in the administration of the Trust and it is also authorized to transact business in connection with the trust.

9. ACCOUNTS & AUDIT:

The Trustees shall maintain Proper accounts and shall adopt the official year as the accounting year of the trust and shall close the accounts of the Trust as on the 31st day of March every year. The accounts of the Trust shall be audited by a qualified chartered Accountant every year.

10. BANK ACCOUNTS:

The Board of Trustees shall open one or more bank accounts in the name of the Trust and all income, subscription and pecuniary donation for the general purpose of the Trust and the income out of investments and all other moneys from time to time forming part of the general revenue of the Trust may be paid in to a bank account or accounts. The Managing Trustee is empowered to operate the bank accounts individually. Cheques and other forms used for withdrawal of money in such accounts shall be signed by the Managing Trustee Who is acting as correspondent. The Board of Trustees



may also decide to increase or decrease the number of Trustees empowered to operate such accounts.

11. MEETINGS:

The founder Trustees along with other Trustees shall convene a meeting of the Board of Trustees to review the functioning of the Trust allowance ones in a month and conduct not less than twelve of such meetings in a year. The meeting shall be conducted on a working day at the Registered Office or such other place as may be decided and a notice of 7 days is necessary before conducting such meetings. The Board may also decide to conduct more number of meetings in a year and also at short notice.

12. QUORUM:

More than fifty percent of the Board of Trustees shall be quorum required for a Board meeting. The Managing Trustee or any one elected among those present shall occupy the chair. The Chairman or Managing Trustee presiding over a meeting shall ensure proper recording of proceeding, happening of the meeting in minute's book.

13. LIABILITIES OF THE TRUSTEES:

The Trustees shall not be liable for any loss that may be caused to the Trust fund unless the Trustee(s) is found guilty of fraud or criminal breach of trust by competent court of law, likewise the liabilities of the trust by competent court of law shall not affect the private assets of the Trustee(s).

14. PROPERTIES OF THE TRUST:

I. All the funds, properties, right claims, demands of every description belonging to or pertaining to the trust now or as may be here after be acquired from time to time shall vest in the Board of Trustees.



II. All investments, deposits and properties of the Trust shall be taken and obtained in the name of the Trust and not in the individual name of the Trustees.

III. At present there is no immovable properties for the Trust.

15. CUSTODY OF TITLE DEEDS, DOCUMENTS OF THE TRUST :


The Managing Trustee or any other Trustee if so authorized by the Board of Trustees shall have the custody of all deeds and documents of title relating to the trust property and investments and the books of account and the records relating to the Trust and shall be responsible for the same.

16. DECLARATION:

The Trust herein created is **irrevocable** and no part of the Trust funds, that is corpus or income, shall in any circumstances whatsoever be paid or lent to or allowed to be applied for the benefit of the Trustees by way of profit, dividends etc., either directly or indirectly. No activities of the Trust will be carried out anywhere outside India. The trust will not carry on any activity with the object of earning profit. Any amendments in the clauses of the trust deed will be carried out only with the prior approval of the Commissioner of Income Tax.

17. BENEFITS OF THE TRUST:

All the benefits of the Trust shall be utilized only for the objects that have been illustrated herein above and shall not be utilized for any personal benefits and uses of Trustees and the entire amount shall be utilized only for the objects of the Trust.




18. MISCELLANEOUS:



I. If at any time the object of the Trust should become impossible of fulfillment, the properties and funds belonging to the Trust shall be utilized for such charitable purposes or to amalgamate with any other Trust having the same or similar objects as the Trustees in office at that time may determine.

II. All the deposits of the Trust moneys shall be made in the name of the Trust in satisfaction of the provisions of section 13 of the Indian income Tax Act 1961.

III. Any instrument and document of title shall be made in the name of the Trust itself.
